STUDENT SELECTION: The student selection process is based on the following point system: (maximum possible points 176)

1. **COURSE/GRADE POINTS** – Points tabulated from the prerequisite courses identified in the admission requirements will contribute to the total points assigned to this category. A total of 31 semester hours of credit are available for point consideration. The method of point calculation for this category is based on the following formula: (Letter Grade value X credits per course = Points assigned).
Total possible = 104
2. **DEGREE POINTS** – If the applicant has a college degree prior to application, points will be added as follows: College Level Certificate = 5 points, AA/AS = 10 points, BA/BS = 15 points, MA/MS = 20 Points. Choose only your highest degree - Total possible = 20
3. **POINTS FOR PRE-REQUISITE COURSES TAKEN AT SJRState** – 2 points will be given for each prerequisite course taken at St. Johns River State College Each Human Anatomy & Physiology course + its lab counts as 1 course. Total possible = 16
4. **POINTS FOR RESIDENCY.** Residence in Clay, Putnam, or St. Johns counties, Florida. (Not required). Add 15 points for residency in the indicated counties.
5. **LICENSURE POINTS** – Current (not expired) licensure/credential in a medical profession. Total possible = 15
6. **HSC 1004 Professions of Caring** – If student has completed the Professions of Caring course, add 6 points for an “A”, 4 points for a “B”, 2 points for a “C”.
