#### Item #2.

Questions Received at Pre-Bid Meeting:

Question #1 Answer #1	Will submittals be required on products? Products cannot be ordered until approved submittal is returned. Yes.
Question #2 Answer #2	What base material is to go around the round columns in the auditorium. Millwork rubber wall base.
Question #3	Carpet base along walls at mezzanine stairs extends up to roughly 12". 10" Tarkett stringer will not cover existing work. Is Tarkett stringer available in larger widths? Possibly14"?
Answer #3	It is understood that the 12" dimension noted in the question above is measured vertically; thus, when rubber stringer is run along the rise of the steps at an angle; a 12" stringer by Roppe ( <i>product data attached – Attachment 'A'</i> ) will work. Confirm field condition prior to ordering any stringer material.
Question #4	Is contractor to remove raised lettering throughout the building, paint, and re- attach lettering? Or paint around lettering?
Answer #4	Refer attached spreadsheet ( <i>Attachment 'B'</i> ) for instructions on scope associated w/ raised lettering within the boundary for scope of work.

Question #5	Can contractor get a schedule for soffit/light cove painting in conference rooms? Some has a small soffit at light cove like in Suites A&B, another has soffit from the wall all the way to the light cove.
Answer #5	Existing soffits if not painted to match the wall color shall remain as existing finish. Existing soffits with wall paint color finish are to be re-finished.
Question #6	Will asbestos testing be required on existing glue or carpet being removed?
Answer #6	For bid purposes assume no asbestos testing is required.
Question #7	Is contractor to paint coffered ceiling soffits in grand lobby?
Answer #7	Painted vertical surfaces of the soffits in the coffered ceiling are not required to be painted.


