Though his typical job duties include patient evaluations and medical interventions, he has spent the past six months primarily providing COVID-19 testing for our community members. Middlebrook states, "During the first wave, I organized and operated two COVID-19 drive-thru testing sites that were open to referrals from any willing medical provider in Putnam County, offering a much needed resource during a time when testing was extremely limited and selective through public health offices."

Middlebrook graduated from SJR State with an A.A. in general studies, an A.S. in Emergency Medical Services, and a B.A.S. in Organizational Management with a specialty in Health Care Administration. Through hard work and determination, he was able to graduate Summa Cum Laude with an overall GPA of 3.88. "I'm honored to be a two-time inductee in the SJR State Hall of Fame for academic achievement, and I served in the SJR State Phi Theta Kappa Honor Society," says Middlebrook.

Since graduating, Middlebrook has applied to the Physician Assistant program at the University of Florida School of Medicine and is awaiting admission with high hopes.
