I want to thank my fellow board members for their passion and dedication to strengthening the Foundation and serving in this capacity!

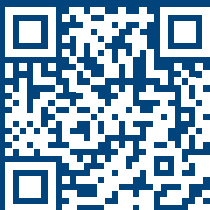

# RANDOM ACTS OF KINDNESS

The Random Acts of Kindness Student Support Fund provides short-term financial assistance to students who face sudden changes in their circumstances that could prevent them from showing up to class or completing the semester. Whether the cause is a death in the family, illness or economic hardship, the Random Acts of Kindness Fund offers one-time emergency needs stipends to students in need in order to help them with rent, utilities, transportation and other expenses while they continue their education.



Students can apply through the Office of the Ombudsman for up to a \$500 one-time stipend. Additionally, students may also receive support from this fund for smaller items, such as, gas cards, food vouchers, shoes and other items. This fund is made possible by the generous contributions from people in our community.

## KINDNESS IN ACTION



A student (AA) going into one of SJR State's Allied Health majors had the unfortunate event of her house being burned down. The student lost their computer and books. Thanks to the Random Acts of Kindness Fund, we were able to purchase the student's books, a new computer and provided a gas card to support their immediate needs.

A current Allied Health student did not have the funds for proper shoes for clinicals and would not have been able to continue in the program without proper shoes. The Random Acts of Kindness Fund was able to purchase two pairs of shoes for the student to complete clinicals, as well as, provided a gas card for the student to get to and from clinicals.



The Random Acts of Kindness Fund has also helped establish the toiletry/hygiene supply baskets on each of the three campuses. Full size toiletries are also available for students who may have a greater need.
